Genacross Lutheran Services fulfills its mission with help from many individuals and organizations. Our theme this year, "You + Genacross," celebrates the fact that others are connected to Genacross and our ministries. The "you" may refer to our dedicated employees, residents, volunteers or donors. It can also mean the families who entrust us with the care of their loved ones or the congregations who support our work. Regardless, we are grateful for our connections to you and that, together, we make a difference.

In 2022, Genacross focused on our Core Value of "Wholeness of Life." In the past two years, the coronavirus (COVID-19) pandemic has taught us many important lessons, including the importance of providing holistic care to those we serve. While the virus physically afflicted many residents, it also devastated many more with loneliness and heartache. People are physical beings, as well as mental and spiritual beings. Recognizing this, Genacross staff strive to look at each person's needs in their entirety, offering not only care and housing, but also spiritual support, meaningful activities and engagement, therapy services, nutritious meals, and more.

During the year, Genacross celebrated the retirement of the Rev. Dr. James Dumke, Vice President for Mission Integration. Dr. Dumke retired after 21 years of faithful service, creating strong relationships with our member congregations and keeping the focus on our mission and values. We also lost one of our long-time leaders and advocates when former President/CEO David Roberts, who led the organization for more than 20 years, passed away. While his accomplishments were numerous during his tenure, he was maybe most known for his passion and enthusiasm for our ministries. Both men left indelible marks on the organization.

Of the year's many highlights, being able to begin serving youth in our Adrian Group Home was one of the most fulfilling. Expanding our youth services into Michigan was a goal we had worked toward for a long time. In addition, we held a successful first-ever Day of Giving, and we honored veterans by providing breakfast for them and their guardians before the Flag City Honor Flights in June and September. We were also blessed to celebrate many of our employees at an in-person staff appreciation event and to establish the Carl W. Klein Jr. Scholarship to support employee career development.

Meanwhile, we made the difficult decision to sell our Bethany Place senior community in Fremont, Ohio. Bethany Place, which had been part of the family since 1999, continues to serve residents with housing and services under its new owners.

During 2022, God blessed Genacross Lutheran Services with the opportunity to serve 2,110 residents, patients, and clients, with 409 staff. They did so with the help of 223 volunteers who provided 3,124 hours of invaluable

service to individuals in our care. Furthermore, Genacross provided nearly \$3 million in charitable care and community benefit.

We are thankful for the many individuals and organizations connected to our ministry. Together, we make a difference in people's lives each day.

Leadership of David I. Roberts led to growth

Genacross Lutheran Services lost a great leader, advocate, friend, and supporter when David I. Roberts, Executive Director and President/CEO from 1994 to 2014, passed away on March 26, 2022. Under his leadership, the organization experienced tremendous growth. Its mission expanded in many ways, including the addition of the 46-acre Wolf Creek Campus in Holland, Ohio, which was the first of the organization's locations to offer an assisted living level of care. Services to youth grew through the addition of the Maumee Youth Center, independent living for young adults, and an alternate learning center. Senior affordable housing options also increased with the addition of seven senior independent living communities that offered service coordination for residents. Mr. Roberts also created a Public Policy Advocacy Plan that enabled the organization to become a national voice on issues affecting youth and the elderly.

Genacross provides Honor Flight breakfasts

In the early morning hours of June 7 and September 13, 2022, staff members from Genacross Lutheran Services, including the Napoleon Campus, Ministry Support and the Wolf Creek Campus, participated in the Flag City Honor Flight events. Employees cooked and served hot, nutritious breakfasts for the veterans and their guardians before they started their long day. The free one-day Honor Flight events fly veterans to Washington, D.C. to tour the memorials built in recognition of their service to our country. It was an honor for Genacross to be able to show a measure of gratitude to these military heroes.

Adrian Group Home begins serving youth

The new group home in Adrian, Michigan, operated by Genacross Family & Youth Services, began serving youth on April 4, 2022. The nearly 5,000 square-foot home, which can serve up to 10 youth at a time, was completed in 2021. However, pandemic-related delays with final inspections and licensing approvals, as well as staffing shortages delayed the opening. The co-ed home provides mental health and behavior stabilization services to youth. Without the Adrian home, youth had to exhaust all possible options in Michigan before being able to receive the services they needed in one of the Family & Youth group

homes in Ohio. The opening of the Adrian Group Home fulfills a long-time goal of Family & Youth Services to provide instate services to Michigan youth.

Genacross sells Bethany Place senior community

On August 1, 2022, the Genacross Lutheran Services' sale of Bethany Place senior community in Fremont, Ohio, to Alpine House of Fremont, LLC became official. Alpine House had been operating Bethany Place as its own property since July 1. Residents living at Bethany Place are continuing to be served with housing and services by the new owners. Since purchasing Bethany Place in 1999, Genacross operated the market-rate apartments for older adults who might not qualify for lower income housing. Service coordination was offered

to help residents age in place. In 2014, the continuum of care was expanded to include assisted living apartments, which enabled residents to remain living at Bethany Place as their needs increased. While the organizations has been blessed to serve the Fremont community for more than 20 years, the sale enables Genacross to invest in other communities it serves.

Bethany Place continues to serve the Fremont community under its new ownership.

WOLF CREEK CAMPUS

When Janet Comer arrived at the Genacross Lutheran Services-Wolf Creek Campus in July 2021, she utilized a mechanical lift and was unable to walk or bear weight. Days before, she had fallen in her apartment and sustained a fracture to her femur. She underwent surgery to repair the fracture at a local hospital and came to the Wolf Creek Campus for her rehabilitation.

A month into her recovery, Ms. Comer was back in the hospital. She had acquired an infection of the surgical hardware. After treatment and more surgery in the hospital, she returned to the campus to resume her recovery.

Ms. Comer remained unable to bear weight on the leg for a little more than two months. Therapy worked diligently with her during this time on safe transfers (without endangering the surgical site) and general strengthening.

After extensive therapy, Ms. Comer began to put weight on the leg in early November 2021, and by February 2022, she was able to put her full weight on it. Therapy continued for months to strengthen her leg, improve mobility, and increase her balance.

"She went through a lot, from the fall itself to being non-weight bearing for months at a time, but she just kept pushing through with a great attitude," said Joe Debortolli, Rehab Director at the Wolf Creek Campus.

While Ms. Comer spent months at the campus recovering, she said her goal was always to return to her apartment at Genacross' Luther Crest senior community, where she has lived for over 12 years. She achieved that goal in May 2022 when she successfully returned home.

HOME & COMMUNITY BASED SERVICES

Cheryl Haney has been a resident of Luther Pines senior community in Lima, Ohio, since 2015. Over the last seven years, she has grown to be quite fond of Luther Pines' Service Coordinator Lanette Briley.

Ms. Haney participates in the routine resident assessment completed by Genacross service coordinators. This assessment identifies resident needs, as well as any gaps in services. The ultimate goal is to help residents remain healthy and living independently for as long as possible.

Ms. Haney is grateful that Ms. Briley has helped her in so many ways. "I could give a million examples," she said, naming transportation and proactive conversations about future services she may need as just a couple.

"The assessment really helps the resident and staff member get to know each other and makes you feel comfortable around each other," she added. "Lanette has always been so nice to me, and she always has an answer for my questions, she added. "I have seen her help a lot of people."

The impact of service coordination plays an extremely important role in residents' quality of life. Genacross is blessed to have staff who not only have the knowledge to assist residents, but also have generous and caring hearts.



GENACROSS AT HOME

To find meaning in your work each day is a gift. Ronda Campbell, Clinical Manager for Genacross at Home for the past five years, knows that gift firsthand. She finds meaning in Genacross Lutheran Services' mission and vision (see page 20).

"Through my work as a Genacross at Home employee, I know that lives are improved, not just those of my clients, but the people I work with as well," Ms. Campbell stated.

Genacross is an authentic organization where individual differences are nurtured, she said. "I am a part of something bigger than myself, and I am allowed to be myself, which in turn is the reason I can do a good job," she added "In my day-to-day work, this company shows me the difference I make through recognition of a job well done."

According to Ms. Campbell, "This company has taught me to lean on each other's strengths and forgive each other's weaknesses." There are times she has had to be reminded of that, but it was done in a way that never made her feel bad. The Genacross message is clear to her: We are greater than the sum of our parts.

Ms. Campbell also knows a price tag may be attached to the job she does, but she has never been made to feel like she is just a number. "In fact, there have been times over the years that I have been made to feel like

I am priceless," she stated.

"Genacross is the place I want to retire from," she stated. "It was a former boss who sought me out to take a position, but it's the company and my co-workers that keep me here."

NAPOLEON CAMPUS

Gib Sonnenberg was born in Henry County and has lived and worked in the area most of his life. Therefore, when the time came to find a place to live that could provide him with assisted living care, Alpine Village at the Genacross Lutheran Services-Napoleon Campus was a logical choice.

Mr. Sonnenberg looked at various assisted living facilities, but, ultimately, he chose Alpine Village because many of his family members have lived at the Napoleon Campus. "My mother was the very first resident when the care

center opened in 1985, and my brother and sister-in-law resided here as well, he said. "They all liked it here and received good care."

"What I like most about living here is the food," said Mr. Sonnenberg, who has lived at Alpine Village since July 2022. "I enjoy a good meal, and I have even put on a few pounds."

Besides meals, Mr. Sonnenberg also receives medication management, housekeeping and laundry services, and access to many activities. In addition, he really appreciates the church services on campus. "If I cannot make it to my own church, they always have a church service here for me to attend," he commented. "I feel that is very important."


"I also have made many new friends here at Alpine Village, and the staff is very friendly and helpful," said Mr. Sonnenberg, who is comforted knowing there are additional care services on the campus if he needs them in the future.



FAMILY & YOUTH SERVICES

Star Harshberger first came to Genacross Family & Youth Services in July 2020 and was placed in the East Toledo Group Home. Star and her siblings had been removed from their mother's home in October 2018 because of abuse and neglect. In the two years before her placement with Genacross, Star spent time in several foster homes, as well as a residential treatment center. Negative behaviors were described as oppositional, attention seeking and aggressive.

While at the East Toledo Group Home, incidents of verbal and physical aggression were frequent and severe, with self-injurious behaviors and suicidal threats observed during moments of crisis. While initially staff thought that Star would be successful in a small group home setting, it became evident that it was negatively impacting her behaviors. To facilitate her treatment and progress, Star transitioned to the Genacross Maumee Youth Center, a larger residential facility.



During the months she spent at the Maumee Youth Center, Star's behaviors improved exponentially. Incidents of oppositional and aggressive behaviors decreased over time, as she developed and implemented appropriate ways to express her emotions. She learned to practice appropriate social skills and create positive peer relationships. Star came to be described as a positive role model, offering encouragement and support to others in moments of need. She worked diligently with her therapist to process her trauma, and she made significant progress in this area. She also developed safe and trusting relationships with staff members.

While Star was making progress toward her treatment goals, plans were going on in her home county to find her an adoptive family. Star first met George and Lucinda Monson in June 2022 through a video call. The couple's knowledge of mental and behavioral health needs and understanding of trauma, their familiarity with services and supports, and their nurturing approach to parenting made them the perfect fit for Star and her needs.


Star continued weekly calls with the Monsons, and their contact eventually progressed to on-site visits, as well as visits to the Monson's home in New York. These experiences allowed Star and the family to build a bond, and they welcomed her into their home in November 2022. Since joining the Monson family, Star has blossomed and has continued to make progress in her behaviors. She is incredibly thankful for the family she has found, as well as the role Genacross was able to play in that process.



Charitable Care and Community Benefit



Part of the mission of Genacross Lutheran Services has always been providing compassionate care to underserved individuals. Once an individual becomes part of the Genacross family, they will not be denied care or services due to the inability to pay. In fact, Genacross provided \$2,922,000 in charitable care and community benefit in 2022.

"This amount was actually quite a bit lower than we reported in the previous year, because of the sale of our Toledo Campus at the end of 2021," said Lorinda Schalk, Senior Vice President of Finance & Operations. "Even with the sale of one of our care campuses, we still provided nearly \$3 million in free care for those in need in 2022."

Through charitable care, Genacross subsidizes the cost of care for residents who do not have the means to pay and meet certain financial criteria. Through community benefit, Genacross provides uncompensated care and services to the uninsured, underinsured, low-income, and indigent residents. Community benefit can be defined as the difference between our cost of providing services and the reimbursements received from third-party insurers, including private pay and government agencies.



Member Congregations

In this instance, "You + Genacross" holds a very special meaning. It refers to the faithful partnership Genacross Lutheran Services has with its corporate membership of 167 Lutheran congregations in northwest Ohio and southeast Michigan. Throughout the years, our member congregations have been valued partners and connections within the communities we serve.

A few of the congregations have been with us from the very beginning. Many have been with us for years. Others have come and gone as the landscape of Lutheran ministry continues to change in the region. Numerous churches support our ministry in one way or another. All of our member congregations, however, have chosen to join Genacross in work that is inspired by the Lutheran tradition of service to those in need. With you - our member congregations – our compassionate ministry to others continues today and into the future.

Our Covenant Partners

Through our Covenant Partner Program, 36 member congregations have chosen to make a further commitment in their support of Genacross ministries. This intentional commitment manifests itself in a variety of ways, including congregation members serving on boards or volunteering at one of our sites, when opportunities are available. Sometimes, Covenant Partner congregations sponsor a Genacross program, activity or project, or they provide financial support through budgeted gifts or special offerings. We are very appreciative of these ongoing partnerships.

One of the lasting effects of the coronavirus pandemic, however, has been the loss of opportunities for volunteers to serve. Volunteers add breadth and depth to the meaningful and engaging activities offered by hard-working staff members. In 2022, Genacross had 223 individuals donate 3,124 hours of service across our ministries. Beside the volunteers interacting with those in our care, there were also individuals who provided leadership and expertise on our boards, and others who worked behind the

scenes to enable Genacross to be better stewards of our resources. You + Genacross, working together to make a difference in the lives of those we serve.

Foth estate gift benefits Genacross ministries

When Chester F. Foth passed away in August 1988, he bequeathed a 6-acre parcel of land in Sylvania Township to Genacross Lutheran Services Foundation upon the death of his wife Helen Stamm Foth. Mrs. Foth passed away in September 2022, and the property transferred to the Foundation.

"We learned that Mr. Foth was a resident of our Lutheran Orphans' Home in the 1920s," said Foundation Executive Director Mike George. "He spoke highly of his time in the orphanage and, hence, his transfer of the land to us."

Mr. Foth's time spent at the orphanage set him on a path for success, and he wanted to share that success with Genacross. He made the needed provisions in his Will to have the property transferred to Genacross upon the death of he and his wife.

"While we are still prayerfully considering what we will do with the property, the Foth gift will impact all our

ministries for generations to come," Mr. George said. "We are so thankful to Chester and Helen for their generosity."

Genacross breaks ground on pocket park

Genacross Lutheran Services held a groundbreaking ceremony on September 14, 2022, for the first of three senior adaptive pocket parks to be built for the residents at its Luther Crest and Luther Woods senior housing campus in west Toledo.

A pocket park is a small park within a community, usually under one acre in size, which is often created on irregular pieces of land. They serve as a focal point of activity and interest, and, in this case, to improve the quality of life for residents.

At Luther Crest and Luther Woods senior communities, the pocket park project was created to offer Genacross residents socialization opportunities and overall health and wellness experiences. These small pocket parks will

each have a different theme, and will be accessible for older adults and those with mobility challenges.

The first park to be built will focus on the environment to promote relaxation and healing. This Environment Pocket Park has been fully funded by Medical Mutual of Ohio and an anonymous fund of the Greater Toledo Community Foundation represented by donor advisor Chuck Stocking. The park is expected to be completed in late spring 2023.



Foundation collaborates with UT honors college

In 2022, the Genacross Lutheran Service Foundation was asked to collaborate with the University of Toledo's Jesup W. Scott Honors College and their community engagement curriculum on a project relating to area nonprofits.



The honors community engagement students are working with the Foundation to conduct research and develop recommendations for a new Volunteer Plan for Genacross Lutheran Services. The coronavirus (COVID-19) pandemic has changed volunteering across many sectors, including nonprofit organizations like Genacross.

The honors students will evaluate current procedures and compare them to industry best practices, and then compile a framework for Genacross to review.

"Collaboration is important to Genacross and its success," said Foundation Executive Director Mike George. "We value our role as a lead institution in the community and want to be able to not only benefit from the use of best practices, but also share them with other nonprofits."



Foundation awards first Klein scholarships

Four Genacross employees were awarded Klein scholarships in 2022 to help offset costs associated with their education and career development. The Carl W. Klein Scholarship was established by the Grigsby family to honor the late Mr. Klein, who served for many years as a member of the Board of Directors.

This competitive scholarship can help full- and part-time employees pay for the cost of tuition for classes that develop their job-related knowledge and skills through an accredited institution.

While much was accomplished in 2022, more work still needs to be done with God's guidance. There are many ways to support Genacross:


